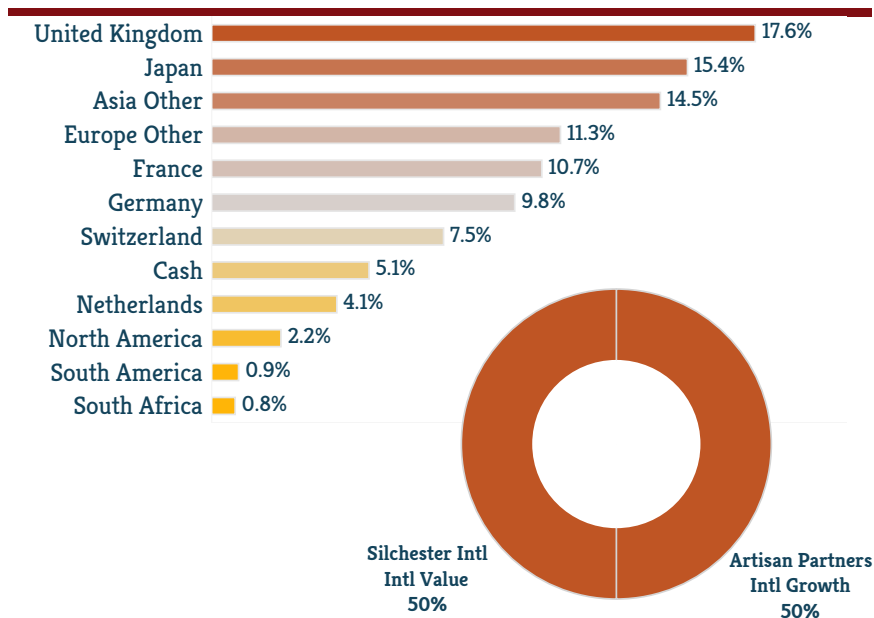

Texas Presbyterian Foundation's International Equity Fund is a broadly diversified portfolio of large, high quality, non-U.S. companies that are either ordinary shares traded on securities exchanges around the world or American Depositary Receipts (ADRs) traded on U.S. exchanges. Geographic, industry and currency exposures are carefully monitored, with limits placed on some individual markets and industries. When appropriate to a particular risk, currency hedges are made. The International Equity Fund seeks long-term growth of capital with no greater risk, but different performance characteristics, than a portfolio of high-quality U.S. securities. 50% of the fund is managed by Silchester International Investors, who seeks to buy financially strong companies at cheap valuations—focused primarily on the developed world. Artisan Partners manages 50% in a fund which invests in growth-oriented international companies selected from themes and industries that present accelerating growth prospects.
